- 7. On <u>Wednesday April 11, 2018</u>, beginning at <u>7:00 p.m.</u>, in the Community Hall at 610 2nd Avenue Bassano, AB., CVRS will hold a preliminary seasonal boat slip assignment meeting, where CVRS will sequentially draw names from the eligible applications received.
- 8. I understand that I must attend the preliminary boat slip assignment meeting to observe the draw and I further understand that attendance at this meeting is **mandatory**.
- 9. I understand that it may not be possible, at the preliminary boat slip assignment meeting, for CVRS to assign seasonal boat slips so that utilization of the seasonal section of the boat dock is optimized. I understand that CVRS may change any boat slip assignment made at the preliminary boat slip assignment meeting in an effort to optimize utilization, in CVRS's sole discretion, of the seasonal section of the boat dock.
- Once CVRS has optimized the assignment of seasonal boat slips, CVRS will contact the selected seasonal boat slips applicants with an offer to enter into a Seasonal Boat Slip Agreement.
- 11. If CVRS offers to enter into a Seasonal Boat Slip Use Agreement with me, and I fail to execute such agreement and to pay the outstanding balance, if any, of the seasonal boat slip fee on Wednesday April 11 2018, I will forfeit my opportunity to rent a seasonal boat slip and my \$220.00 application fee will be forfeited to CVRS.
- 12. If I enter into a Seasonal Boat Slip Use Agreement and pay all amounts owing, my \$220.00 application fee will be applied to the seasonal boat slip fee for my seasonal boat slip.
- 14. If my name is not drawn or if CVRS does not offer to enter into a Seasonal Boat Slip Use Agreement with me, CVRS's only obligation to me is to return my **\$220.00** application fee.
- 13. If, at the conclusion of the boat slip assignment meeting or at any time thereafter, one or more seasonal boat slips remain available, I understand that CVRS can deal with such seasonal boat slips, as it deems appropriate.
- 14. I hereby accept the rules and procedures as outlined in this application form including the terms and conditions set out in the **2018** Seasonal Boat Slip Use Agreement.
